## GENERAL CONTRACT CONDITIONS / Camping de la Plage – Saint Cirq Lapopie

All rental contracts are non-transferable.

The number of persons and vehicles per location/rental must be respected. Additional vehicles are parked on the outdoor parking.

All the persons must abide the terms of this contract. Each tenant in title is responsible for the disturbances and nuisances caused by persons who stay with him or visit him.

### THE VISITOR

You have to ask at the reception to receive visitors, they have to be inscribed. They respect the campsite rules and they are under your responsibility.

### RESERVATION

Pre-booking is effective as soon as the contract is signed and the deposit is received (by credit card or bank transfer). Camping de la Plage will confirm the booking by mail.

### PAYMENT

The balance must be paid one month before the arrival. In case of booking less than one month, you have to pay the entire stay.

The balance must be paid within the time limit or the stay will be cancelled. In all events, the campsite will retain accounts.

### RATES AND TOURIST TAX

The rates TTC are including tourist taxes. Tourist taxes are collected on arrival.

### CANCELLATION

You can purchase an annulation among your personal insurance. You could also contract an insurance to [www.ffcc.fr](http://www.ffcc.fr) (01.42.72.84.08).

Change your booking can be made toll-free subject to availability. In absence of a message from you indicating a postponement of your arrival date, the accommodation may be available for sale 24h after date of arrival mentioned on the contract and you will therefore lose the benefit of your booking.

Any stay interrupted or shortened by you may not give rise to a refund. In case of cancellation of Camping de la Plage, except in case of force majeure, your stay will be refunded. However, this cancellation shall not entail in payment of damages.

Any cancellation of reservation must be made in writing. The refund of the sums paid will take place net of the amounts specified below. If the cancellation occurs:

- More than 30 days before the start date: the down payments will be kept by the campsite.
- Less than 30 days before the start date: 100% of the amount of the stay is required.

### INSURANCE

Every customer must have all the insurance that guarantees the risks of theft, fire, water damage, civil liability, recourse of third parties.

Management disclaims any responsibility for theft, loss, degradation, fire... and in event of an incident of civil liability for the camper.

### ARRIVAL AND DEPARTURE

Park your car on the waiting parking and come by foot at the reception for registration. One place of parking is available for disabled persons.

For rentals, arrivals are between 4 p.m. and 7 p.m. You must inform reception before if you are going to arrive after. Departure is before 10 a.m. after inventory check-out (appointment fixed at the arrival). In case of early arrival, the client will have to wait the rental be ready.

For pitches, arrivals are between 2:30 p.m. in low season / 2 p.m. in high season and 7p.m., departure is before 11.45 am.

For pitches and rentals, arrivals must be made during reception opening hours (high and low season).

In cases of early departure, the inventory check-out must be arranged with Reception. The total amount for the dates specified at the time of reservation will be paid.

In cases of late arrival: reception must be informed in order to arrange an arrival time. If the campsite is not informed within 24h, it may re-rent the pitch(es) or/and rental(s).

### DEPOSITS

A deposit of 20 € is required for the entrance barrier badge.

For rental, 300 € is requested as a deposit on arrival. If rental has been cleaned and there is no damage, this deposit will be returned after the inventory check-out. If the rental has not been cleaned or has suffered damage, the deposit will be retained and the bill for any damage presented. Additional compensation can be asked in case of costs exceed the amount of deposit.

### COMPUTER SCIENCE AND LIBERTY

All pictures and texts are not contractual. Your private informations are confidential. You authorised Camping de la Plage to use pictures of you or your family for advertising and entertainments. You must write us if you don't agree.

### INVENTORY CHECK

Full cleaning of rental and surrounding area is on your responsibility, otherwise a cleaning package of €60 will be requested. You can also request this cleaning package (€60) when you book or when you arrive at reception

An inventory entry is made before your arrival and you have 24h to inform reception of any comments. For the inventory check-out, an appointment is set together at your arrival.

### HEALTH CRISIS

In case of health crisis, you and persons accompanying you must respect the health protocol put in place on the campsite, social distance and application of barrier gestures.

### SECURITY

Camping de la Plage site is in a flood zone. The Lot can leave its banks in winter after heavy rain upstream. Flood alerts are always given.

Individual barbecues are forbidden without permission. A common barbecue is available on the area games. Fire extinguishers are available throughout all the campsite. In case of fire or any other incident please inform reception immediately. Please follow the evacuation plan (displayed in public places) and take the exits on foot.

No violent games are allowed.

Please notify reception of any matters concerning safety.

### CHILDREN

Minors must be accompanied by their parents or their legal guardians. They cannot stay alone in the campsite. Parents or legal guardians are legally responsible for them.

### PLAYGROUND AND ACTIVITIES

The playground is forbidden after 11 p.m.

For activities you have to respect rules, some of them could be cancelled.

### ANIMALS

1st and 2 class are not allowed on the campsite.

Dogs and other animals which are not dangerous are accepted on presentation of the vaccination certificate. Dogs must be kept on lead and supervised all times by their owners.

Their excrements must be cleaned away and any remaining dirt cleaned up by the owners. Animals are not allowed in sanitary blocks, laundry, playground, beach, restaurant and snack.

### CLEANLINESS AND ENVIRONMENT

Toilets are cleaned and garbage cans are picked up several times a day. Thank you for keeping the place clean. Everyone is obliged to refrain from any action that could affect cleanliness, hygiene and appearance of the campsite.

Smoking is not allowed in rental and public spaces. Thank's to put cigarettes in ashtray.

The areas for washing and chemical waste disposal must be treated with respect.

### SUSTAINABLE DEVELOPMENT

The site is in a sustainable way (recycling containers and bottle bank).

An attention to saving energy is required.

The natural and human environment must be respected.

### RESPECTS

Silence must be respected after 23p.m. throughout the campsite.

Within the campsite, the speed limit is 10 km/h. Movement of vehicles is forbidden between 11 p.m. and 7 a.m.

Vehicle must be parked on the emplacement and must not hinder the passage of other vehicles or get in the way of new arrivals.

Respect for neighbours, employees and campsite managers is expected.

### PENALTIES

All clients undertake to respect this rental contract and campsite rules.

Any degradation act committed will be at the responsibility of its author.

Any behaviour intended to disturb campsite general order may result in the immediate exclusion of the establishment (alcohol, narcotics, degradation, theft, repeated noise, provocative and indecent behaviour, ...).

### PROCEEDINGS – CLAIM

The site is not responsible for poor reception of DTT or Wifi.

All complaints should be referred to reception.

In case of dispute, jurisdiction is delegated to the nearest tribunal of the campsite.
